INVESTMENT FUNDS ACT, 2019 (NO. 2 OF 2019)

INVESTMENT FUNDS (FEE) RULES, 2020

The Securities Commission of The Bahamas, in exercise of the powers conferred by section 160 of the Investment Funds Act, 2019 (*No. 2 of 2019*), makes the following Rules –

1. Citation.

These Rules may be cited as the Investment Funds (Fee) Rules, 2020.

2. Interpretation.

- (1) In these Rules –
“**Act**” means the Investment Funds Act, 2019 (No. 2 of 2019); and
“**Commission**” means the Securities Commission of The Bahamas.
- (2) Words and phrases not defined in subsection (1) and used in these Rules shall, unless the context otherwise requires, have the same meaning ascribed to them in the Act and Regulations.

3. Fees.

- (1) For the purpose of the Act and the Investment Funds Regulations, 2019, the fees set out in the Schedule shall apply.
- (2) All fees set out in the Schedule shall be paid to the Commission of The Bahamas, and shall not be refundable.

4. Annual Fees.

- (1) The annual fees set out in Tables A to E of the Schedule shall be payable in accordance with the period established by section 43 of the Act.
- (2) The annual fees payable in the first year of licensing or registration of a regulated person and the approval of a principal office shall be pro-rated to the 31st day of December from the date of licensing, registration, or approval of that year.
