### AROUND THE COMMISSION

**20 February 2020:** The Commission and Compliance Commission conducted a successful joint FCSP Authorised Agent Training webinar for BICA-licensed accountants and accounting firms to qualify as authorised FCSP examiners. 66 individuals from 31 entities participated.

**27 February 2020:** The Risk Analytics Unit conducted a Regulatory Capital webinar information session to assist SIA registrants in properly preparing Regulatory Capital calculations for inclusion on quarterly filings of Form 13--Financial and Operational Report. 80 individuals from 56 entities participated.
