REGULATORY UPDATES

On the Horizon

Financial and Corporate Service Providers Bill, 2020 final review is being concluded.

Securities Industry (Business Capital) Rules 2020 have been reviewed and finalized and are awaiting signoff.

The Digital Assets and Registered Exchanges Bill, 2020 (DARE) will regulate initial token offerings (ITOs), digital asset businesses, including digital token exchanges, sponsors of ITOs and digital custody services and other digital asset service providers. Once enacted, any person conducting digital asset business in or from The Bahamas will require registration under the Act.

EXTENSION OF STATUTORY FILINGS DEADLINES

The Commission granted an extension to certain filing deadlines for SIA and IFA registrants and licensees. Effective immediately, deadlines which fall between 1 April 2020 and 30 June 2020 inclusive, for the filing of audited annual financial statements and annual reports, as required pursuant to the SIA and IFA, are extended by up to 45 days. DESK-BASED THEMATIC REVIEWS

The Commission is conducting industry-wide, desk-based thematic reviews to obtain information about business operations from all SIA/IFA/FSCPA registrants and licensees. The reviews will assess compliance with industry standards. The first survey, disseminated on 6 July, focuses on antimoney laundering and countering the financing of terrorism procedures and practices, and business continuity plans. The survey is mandatory for all regulated entities and is presented as an e-fillable form, consisting of short form responses and multiple choice questions.
