## Draft Investment Funds (Fees) (Amendment) Rules, 2020

The Securities Commission of The Bahamas (the Commission), in its capacity as the regulator of investment funds, securities and the capital markets, has issued the Draft Investment Funds (Fees) Rules, 2020, for public consultation.

## Summary

The Draft Investment Funds (Fees) Rules, 2020 prescribes the fee requirements for firms and individuals carrying on investment funds business in or from within The Bahamas.

### Scope

These Rules will apply to all registrants and licensees under the Investment Funds Act, 2019 and any such firm or individual to be registered or licensed under the Investment Funds Act, 2019; including investment funds, investment fund administrators, investment fund managers and any other parties related to investment funds.

### **Consultation Period**

The consultation period commences **Friday 6 November 2020** and ends on **Friday 20 November 2020**, during which time the Commission invites the public to share comments with regard to the Rules. Comments received within this period will be taken into account.
