# Draft Securities Industry (Fee) (Amendment) Rules, 2020

The Securities Commission of The Bahamas (the Commission), in its capacity as the regulator of investment funds, securities and the capital markets, has issued the Draft Securities Industry (Fee) (Amendment) Rules, 2020, for public consultation.

### Summary

The Draft Securities Industry (Fee) (Amendment) Rules, 2020 prescribes the fee requirements for firms and individuals carrying on various categories of securities business pursuant to the Securities Industry Act, 2011.

#### Scope

The amended Rules will apply to any person registered under Part V, VI, XI and XVII who may be required to pay an application fee, registration fee, annual renewal fee, filing fee or administrative fee pursuant to the Securities Industry Regulations, 2012.

#### **Consultation Period**

The consultation period commences **Friday 6 November 2020** and ends on **Friday 20 November 2020**, during which time the Commission invites the public to share comments with regard to the Rules. Comments received within this period will be taken into account.

## SECURITIES INDUSTRY (FEE) (AMENDMENT) RULES, 2020

The Securities Commission, in exercise of the powers conferred by section 22 of the Securities Industry Act, 2011, (No. 10 of 2011), makes the following rules –

## 1. Citation and Commencement.

These Rules may be cited as the Securities Industry (Fee) (Amendment) Rules, 2020.
