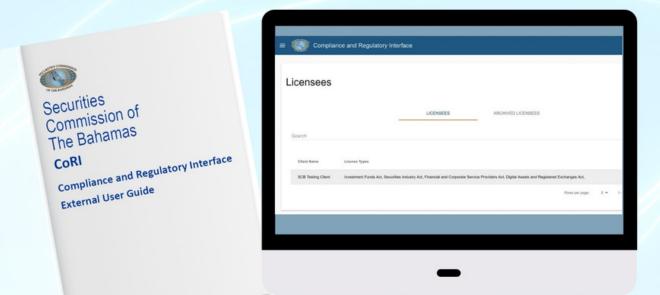

## **FILINGS WATCH**

Licensees and registrants under the Securities Industry Act, 2011 (SIA), the Investment Funds Act, 2019 (IFA) and the Financial and Corporate Service Providers Act, 2020 (FCSPA) should refer to legislation and issued rules in order to remain compliant with their ongoing reporting obligations.

## **AROUND THE COMMISSION**

**22 Jan 2020:** Launch of the Commission's Compliance and Regulatory Interface (CoRI) – a web-based portal for submission of application forms, regulatory filings and supporting documents to SCB electronically. The e-forms on the platform mirror the information/reporting requirements of prevailing, approved forms for the acts administered by the Commission. CoRI is a part of the initiative to improve data collection and analysis, to better inform SCB's supervisory efforts.

25 Jan 2020: Dissemination of CoRI External User Guide to registrants and licensees to assist with utilisation of the portal.

## DESK-BASED THEMATIC REVIEWS

the Commission developed three desk-based, industry-wide thematic reviews to obtain business operations information from all SIA/IFA/FSCPA registrants and licensees. The first two surveys, competed in July 2020, focused on anti-money laundering and countering the financing of terrorism procedures and practices (AML/CFT/PF), and business continuity plans. The Commission will publish the results upon completion of its analysis. The results informed the Commission's 2021 Priorities. The third desk-based thematic review on the suitability of complex financial products is pending release.
