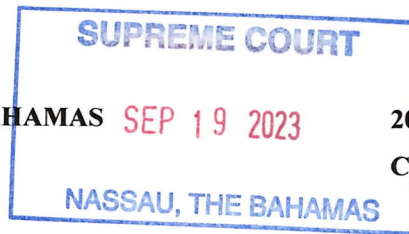

**UPON THE APPLICATION** of The Securities Commission of The Bahamas by Ex Parte Summons filed herein on the 15<sup>th</sup> day of September, 2023 (heard Inter Partes)

**AND UPON HEARING** Mr. Michael R. Scott, K.C., along with Ms. Marnique Knowles, Mr. Gawaine Ward and Ms. Aramantha Hepburn, for the Applicant and Mr. Kahlil D. Parker KC with Roberta W. Quant and Lesley A. Brown for the Respondent.

**AND UPON READING** the Affidavit of Christina R. Rolle filed herein on the 15<sup>th</sup> day of September, 2023

**IT IS HEREBY ORDERED BY CONSENT** that the Respondent be and is hereby restrained and prohibited from:

- i) Trading in all securities and/or soliciting of crowdfunding activity via the platform operating as Arawak X;
- ii) Promoting trading in any securities generally; and
- iii) In any way facilitating any activity on the Arawak X platform for or by any person and/or soliciting any new funds from any person, including new or existing clients or

investors in MDollaz, any issues, project initiators and/or promoters of crowdfund offerings as well as new investors in crowdfund offerings;

- iv) In any way handling or dealing with money or assets presently held on account of or to the order of existing clients of MDollaz Ltd or Arawak X.
- v) Promoting MDollaz and/or the platform ArawakX in any way whatsoever; and
- vi) Seeking to raise additional capital and/or investment in MDollaz from Members of the public, including accredited/professional investors.

Until after Friday the 13<sup>th</sup> day of October A.D. 2023, or further order in the meantime.
