SECURITIES INDUSTRY (FEES) RULES, 2024

The Securities Commission, in exercise of the powers conferred by section 31 of the Securities Industry Act, 2024 (No. 39 of 2024), makes the following rules —

1. Citation.

These Rules may be cited as the Securities Industry (Fees) Rules, 2024.

2. Fees.

The fees set out in the Schedule shall apply in relation to the Act unless exempted by the Commission, and be paid to the Commission and shall not be refundable.

3. Annual renewal fees.

- (1) All annual renewal fees set out in the *Schedule* shall be payable on or before the 31st day of January in each year.
- (2) The annual fees payable in the first year on the grant of registration shall be pro-rated from the date of registration to the 31st day of December of that year.

4. Exemption.

A person desirous of conducting contract for differences activity shall be required to pay the application, registration and annual fees for the contract for difference but shall be exempt from the application, registration and annual fees applicable to dealing, arranging deals, managing or advising on securities.

5. Revocation of S.I. No. 190 of 2020.

The Securities Industry (Fee) Rules, 2020 are hereby revoked.
