**DIGITAL ASSETS AND REGISTERED EXCHANGES
(FEES) RULES, 2024**

The Securities Commission of The Bahamas, in exercise of the powers conferred by section 79 of the Digital Assets and Registered Exchanges Act, 2024 (*No. 40 of 2024*), makes the following rules —

1. Citation and commencement.

- (1) These Rules may be cited as the Digital Assets and Registered Exchanges (Fees) Rules, 2024.
- (2) These Rules shall come into operation on 31 December, 2024.

2. Fees.

The fees set out in the *Schedule* shall apply in relation to the Act unless exempted by the Commission and shall be paid to the Commission and shall not be refundable.

3. Annual renewal fees.

- (1) All annual renewal fees set out in the *Schedule* shall be payable on or before the 31st day of January in each year.
- (2) Annual renewal fees payable on the grant of registration shall be pro-rated from the date of registration to the 31st day of December of that year.
