

What is a Ponzi Scheme

A **Ponzi** scheme involves a central fraudster gathering money from new "investors". They then use those funds to pay supposed returns to earlier "investors", instead of actually investing or managing the money as promised.

These schemes typically unravel when the fraudster can no longer bring in new investors or when too many investors try to withdraw their money at once.
